DEFINITION: A used bike, tire and battery licensee shall buy, sell, exchange or deal in used or secondhand bicycles, bicycle parts, tires and batteries, either retail or wholesale.

LICENSE PERIOD: Biennial; expires March 31 in even-numbered years.

LICENSE FEE: \$75; **Fee must be submitted with application.** Checks made payable to: *City of Milwaukee*. Credit cards are also accepted online and in-person; cash is accepted from applicants filing in person only. When you provide a check as payment, you authorize us either to use information from your check to make a one-time electronic fund transfer from your account, or to process the payment as a check transaction.

EXEMPTIONS FROM APPLYING:

Licensees applying for or holding a Secondhand Motor Vehicle Dealer License, a Used Motor Vehicle Dealer Parts Only License or an Auto Wrecker license are not required to obtain a Used Bike, Tire and Battery License.

APPLICATION:

Complete, sign and return application to City Clerk License Division, City Hall, Room 105, 200 E. Wells Street, Milwaukee, WI 53202. Use your full legal name in completing the application.

[!] Incomplete applications as well as applications submitted without the required fee and signature will be RETURNED.

SIGNATURES REQUIRED:

Notarized signatures of the individual, all partners, the agent of a corporation or a LLC are required. All commissioned notaries public, including attorneys, must impress their notary seal on the notarial certificates they issue. Applications submitted without the required seal will be returned.

REQUIREMENTS:

Applicants must be 18 years of age or older.

An occupancy permit must be obtained from the City of Milwaukee, Development Center, Permit Desk, (414) 286-8211, located at 809 N. Broadway, 1st floor.

FINGERPRINTS:

All applicants (including all partners, all corporate officers, members, agent, director, manager, and stockholders owning 20% or more of the stock of the corporation) whose fingerprints are not on file with the Milwaukee Police Department must be fingerprinted. Report to the Milwaukee Police Report report between the hours of 8:00 AM and 6:00 PM (Monday thru Friday, excluding holidays) to the Police Administration Building, 951 N. James Lovell Street (7th St), Room 305 to be fingerprinted. If you have previously been fingerprinted by the Milwaukee Police Department, call (414) 935-7281 to determine whether your fingerprints are still on file.

Renewal applicants do not need to be re-fingerprinted by the police department.

If you do not reside locally, call (414) 935-7281 to find out how to comply with the fingerprint requirement.

GRANTING:

After recommended approval by the Licenses Committee, licenses are granted by the Common Council at regularly scheduled meetings, which are usually held once a month. It generally takes about 5-6 weeks to process an application provided you follow the above instructions in a timely manner. Please note that no meetings are held during the month of August.

CHANGES IN BUSINESS OPERATIONS:

If after a license has been granted, a licensee wishes to substantially deviate from the business operations (from retail to wholesale, or wholesale to retail) that were listed on the original application, the licensee must file a notarized statement with the City Clerk License Division, which states the change in the type of business operation. No change in business operation shall take place until the common council has approved the request.

PARTIAL REFUND OF LICENSE FEE: If an application is withdrawn or denied, you are eligible for a partial refund, provided the refund is requested no later than one year from the date of withdrawal or denial of the application. If a license is not issued, the refund must be requested no later than one year from the date of application, unless the license has been granted, in which case no later than one year from the date of granting of the license.

Any person who submits in writing any untrue statement or affidavit to the city in connection with any such license or application shall be subject to a forfeiture of not more than \$500 or in default a payment therefore shall be imprisoned in the county jail or house of correction for Milwaukee County for not more than 20 days; and that license, if granted, shall be subject to revocation and no license of any kind or nature issued under chapter 93 shall thereafter be granted to such a person for a period of one year from the date of revocation.
