

**RETURN WITH YOUR BID RESPONSE**

**MINIMUM SPECIFICATION FOR THE RENTAL OF  
FOUR-WHEEL DRIVE LOADERS WITH BUCKET  
(HIGHWAY)**

**1. SCOPE AND CLASSIFICATION**

- 1.1 It is the intent of this specification to describe the requirements for the rental of four (4), FOUR WHEEL DRIVE LOADERS with BUCKETS. The rental period would be from 6-10-08 to 6-9-09.**
- 1.2 Successful bidder shall invoice monthly Milwaukee County Highway Department for the loader rental.**
- 1.3 This agreement may be extended on a year-to-year basis with the approval of Milwaukee County and the successful bidder.**
- 1.4 The bidder will quote the monthly charge for the loader, which shall include any required maintenance. The charge will be based on 40 hours of use per month. Any unused hours may be used in subsequent months of the rental agreement with the charge for excess hours of use commencing at 240 hours. The bidder shall quote the excess hour charge as part of their bid.**

**2. DOCUMENTS**

- 2.1 Each vendor shall provide two (2) sets of bid documents including informational/promotional literature that describes the unit bid.**

**3. REQUIREMENTS**

***THE COMPLIANCE SPACE MUST BE COMPLETED THOROUGHLY AND ACCURATELY. IF VENDOR CHECKS "NO" TO MEETING ANY OF THE SPECIFICATIONS, THEY MUST INCLUDE A WRITTEN EXPLANATION AND ATTACH IT TO THE BID.***

**3.1 FOUR WHEEL DRIVE LOADER**

**3.1a MAKE/MODEL**

- 1. The units bid shall be a John Deere Model 744J, Caterpillar Model 950H, Case Model 921E, Komatsu Model WA380-6. No substitutes shall be accepted.**

**3.1b ENGINE**

1. The engine shall be a six cylinder, in-line direct injected, turbo-charged four-stroke diesel engine, with a minimum 185 net horsepower.
2. Auxiliary engine fuel priming pump.
3. Engine block heater

**3.1c CHASSIS**

1. Ride control system for smoother transport and material retention.
2. Cab controlled switch for coupler hydraulic lock pins.
3. Loader shall have a minimum operating weight of 40,000 pounds.

**3.1d TRANSMISSION**

1. Power shift with automatic shift capability.
2. Limited slip differentials.

**3.1e TIRES**

1. Four 23.5-R25 L3 radial tires.

**3.1f CAB**

1. The cab shall have a heater and defrost system to keep all windows clear.
2. Mounting provisions shall be made for the installation of Milwaukee County radios. The actual mounting shall be the responsibility of Milwaukee County with approval from vendor.
3. A ten pound fire extinguisher shall be mounted inside of cab.

**3.1g ELECTRICAL**

1. Two (2) top mounted forward flood lights, two (2) front work lights, two (2) front driving lights and two (2) top mounted rear flood lights.
2. One Preco Model 3614A strobe light with protective guard and collapsible mount shall be installed on the roof of the cab by Milwaukee County. The cab must be prewired and have a toggle switch installed that will activate the light.
3. Back-up alarm, self-adjusting Smart Alarm.

**3.1h ATTACHMENTS/ACCESSORIES**

1. Four and one-quarter (4.25) yard general-purpose bucket with bolt-on reversible cutting edge.
2. Bucket shall be removable to facilitate storage of the unit.

**4. GENERAL SPECIFICATIONS AND INSTRUCTIONS**

**4.1 CURRENT MODEL**

- 4.1a The equipment bid may be new or used, however it shall be the current model built by the manufacturer, under factory warranty and delivered completely assembled and ready for operation at the time of delivery.

**4.2 PARTS AND SERVICE**

- 4.2a The vendor must have an authorized parts and service facility, within 110 miles of Milwaukee County, with a sufficient stock of parts and trained technicians to service the equipment bid.

**4.3 TRAINING**

- 4.3a The successful vendor shall at a time mutually agreeable with Milwaukee County, provide up to four (4) hours of training to operators and service technicians covering the operation and maintenance of the equipment, if required.

**4.4 WARRANTY**

- 4.4a** The unit must be covered under full factory warranty for the entire duration of the rental. The vendor will provide a loaner loader if the rental unit needs a machine down repair.
- 4.4b** The vendor will be responsible for any regularly scheduled maintenance and Milwaukee County will be responsible for any daily maintenance.
- 4.4c** Should any vehicle in this bid encounter a defect while under warranty, the vendor will be responsible for all cost associated with transporting the vehicle to and from an authorized service facility.

**4.5 DEMONSTRATION**

- 4.5a** Milwaukee County reserves the right to request a demonstration of any bidder's proposed equipment prior to issuance of a purchase order.

**4.6 PRICE AND DELIVERY**

- 4.6a** The price bid for the equipment must be **NET PRICE DELIVERED**. Any bid modifying or "escalator" clauses will not be considered.
